## **SPECIALTY TRACK STUDY GUIDE**

### **Logistics Officer**

### **FOREWORD**

Although the logistics career field is very broad within the Air Force, it is relatively restrictive within Civil Air Patrol. The logistics field consists of aircraft maintenance, transportation, and supply.

CAP maintenance officers are the managers of aircraft maintenance, not the doers. Although they may perform user-authorized maintenance, their primary duty is to supervise. To actually perform aircraft maintenance would require FAA certification. That certification is not within the scope of CAP. Although the transportation officer may more easily be the vehicle maintenance individual, the primary duty is, again, supervision. The supply officer is, again, a supervisor, but in many cases will actually administer as well as supervise the overall supply operation. The logistics officer may hold all three positions in small units while in larger units there may be several individuals within each area.

Proficiency is gained by experience, over time. The more you do the job, the better you will perform the various tasks. All the tasks in the CAP logistics areas are outlined in the attached study guide. No supplementary data other than the referenced publications is needed. However, before you can be awarded a rating, you must complete all requirements in the next lower level of the senior member training program (ex., prior to award of the technician rating, you must complete all Level I requirements; prior to award of the senior rating, you must complete all Level II requirements; and prior to award of the master rating, you must complete all Level III requirements).

Your commander can award you the technician, senior, or master rating after you complete the readings in this study guide, meet the appropriate level requirements mentioned above, and perform the required tasks of the assigned specialty track. The award of a rating should be documented on the CAP Form 45 and updated on the unit Senior Member Training Level Report (SMTLR) by the senior program officer.

## LOGISTICS

**1. Position Description.** The position description below, for supply, transportation, and aircraft maintenance, include the duties for all three ratings (technician, senior, and master):

**a. Supply.** As supply officer, you are responsible for all matters pertaining to supply. You shall:

- ensure proper accountability for all CAP property.
- be responsible for receipt, issue, storage, and proper disposal of all CAP property.
- be responsible for effecting distribution and recovery of property in coordination with the transportation officer.
- recommend to the commander the allocation or reallocation of property within the unit.

**b. Transportation.** As transportation officer, you are responsible for all matters pertaining to surface and air transportation. You shall:

- ensure that all vehicles are licensed and insured and that drivers are qualified and licensed to operate the vehicles.
- recommend allocation and reallocation of motor vehicles.
- maintain appropriate records on location of all vehicles.
- be responsible for maintenance, painting, and marking vehicles.

**c. Maintenance.** As maintenance officer, you exercise staff supervision and coordination of all aircraft maintenance. You shall:

- make recommendations to the commander for the improvement of the maintenance program.
- ensure that aircraft are painted and identified in accordance with current directives.
- ensure that aircraft are maintained in an airworthy condition in accordance with FAA requirement.

**2. Objectives.** To develop an understanding of the basic workings of the logistics function. To prepare a person to manage either all of the logistics requirements of a unit, or a specified area within the logistics function (i.e., supply, transportation, or aircraft maintenance).

### 3. Functions and Responsibilities:

**a. Knowledge requirements.** Listed below are subject areas and publications with which you'll work and need to be familiar. Read the publications for your area as soon as possible after assuming duties. Use this list as a quick reference when searching for information related to specific areas/questions. The abbreviations to the left indicate what duty position is usually responsible for the listed area.
